

# MANAGER DEVELOPMENT PROGRAM

## Program Description

The Manager Development Program (MDP) is a comprehensive learning path that assists out-of-scope managers in levels 6 to 9 in the development of skills and competencies that lead to high performing teams. In 2020, MDP was enhanced by integrating and aligning the five Middle Manager Excellence (MME) roles into the program. Each learning and development opportunity is now aligned to one of the five roles including: a) Enabling Individual Performance, b) Managing Teams and Relationships, c) Lead Strategy Implementation, d) Facilitate Collaboration, and e) Manage Information and Administration.

## Program Requirements

Any out-of-scope manager from MCP06 – 09 are eligible. This includes eligible managers from any region/ministry in the province. While there is no formal approval process for registering into the learning path, any new potential registrants are encouraged to meet with their manager and discuss how participating in the program could benefit their professional development.

To complete the Manager Development Program, learners must complete the following:

**Foundational Knowledge and Skills Requirements** - Complete 9 courses including the 6 mandatory courses.

### Five Core Competency Requirements:

1. Lead Strategy Implementation – Complete 3 courses
2. Enable Individual performance – Complete 3 courses
3. Manage Teams and Relationships – Complete 3 courses
4. Facilitate Collaboration – Complete 3 courses
5. Manage Information and Administration – Complete 3 courses
