Key Responsibilities of position:

The successful candidates will be professionals who will commit to teamwork and who have effective communication and interpersonal skills. Our candidates of choice will work with a team of health care professionals to provide direct patient nursing care and treatment. They will maintain accurate patient records, actively promote preventative health measures, respond to medical/psychiatric emergencies with appropriate interventions and assess medical and mental conditions, making referrals as needed. To be considered for this position, you will be actively registered (or eligible for registration) with the Registered Psychiatric Nurses Association of Saskatchewan (RPN) or the Saskatchewan Registered Nurses Association (RN). You must have knowledge of medical and psychiatric theories and related intervention strategies; drug/alcohol withdrawal indicators and effects; communicable diseases in a correctional population; public health issues and risk factors; and knowledge of multicultural beliefs, values and perspectives. The successful candidates will work: day, evening, week and/or weekend shifts. The successful candidates must be an advocate for their patients, be honest and reliable, and treat everyone with dignity and respect. They must also be committed to the pursuit of excellence, exhibit leadership and professionalism, embrace diversity and equality, and be responsible and accountable. You will have knowledge of: - medical and psychiatric theories and related intervention strategies; - drug/alcohol withdrawal indicators and effects; - communicable disease priorities within a correction population; and - public health issues and risk factors. You will have demonstrated the ability to: - provide leadership and direction to colleagues and patients in support of a work environment that recognizes, supports, respects multi-cultural beliefs, values and perspectives, with particular emphasis on First Nations and Métis; (leadership – multi-cultural beliefs) - identify and assess physical and mental health care needs, including risk assessment and crisis intervention to determine and/or implement an appropriate care plan in an accurate and timely manner; (analytical skill) - record, organize and present, verbally and in writing, information in a complete, accurate and timely manner at a level that is appropriate to the audience; (communication skill) - work independently, co-operatively and as a contributing member of a team of professionals to meet client and ministry goals and objectives;(team/independence skill) - develop and maintain respectful, honest, and professional relationships with a challenging and diverse range of clients; and (interpersonal skill) - recognize and evaluate safety or potential risks to self and others, taking appropriate and preventative action, using good judgment.
